12. <u>Council to review and approve monthly updates from Molzen</u> <u>Corbin, Kevin Eades</u>

HSIP Patricio Garcia- NMDOT is reviewing a change order document for additional runoff mitigation on site as well as providing additional funding for the project to cover field changes authorized by NMDOT during construction. Once the change is approved, TLC will remobilize to complete the project. Working with NMDOT and FHWA to close out the project to give the Village and additional \$115,000 +/- to pay for changes during the project as initiated by NMDOT.

Sewer Collection System Addition- Contractor is FILE construction. Construction was suspended and will resume per Village direction, pending coordination with residents for service. The project may require a funding extension.

Well #3- \$25,000 of previous remaining Capital Outlay. \$50,000 Capital Outlay (2018). \$250,000 Capital Outlay (2019). Village has approved up to \$225,000 of self-funding to advance this project for drilling. The well design is complete, NMED-CP and Drinking Water Bureau have approved design. Council was to award to Rodgers and Co on Dec 23rd. Awaiting Tijeras compliance with Financial Reporting for concurrent award. Once the well is constructed and tested, the well equipment and building can be designed PNM electrical service as well to the site.
