9. Council to Review and Approve ZA 1117, Village of Tijeras, 8 Camino Municipal

Mayor Bruton explained ZA 1117 refers to the drive-in theater and the Council previously approved it. He added the application has gone through the Planning and Zoning Commission and the Village requires a variance, as the structure will be 30 feet tall and the ordinance imposes a limit of 26 feet. Mayor Bruton also noted the project is well within required setbacks and there is support in the community for it.

Councilor Johnson asked about the date of the first showing and the film to be shown. Mayor Bruton replied the first showing would be the film *Beetlejuice* or *Haunted Mansion* on the evening of October 31st. Councilors Johnson and Y. Garcia expressed their support for *Beetlejuice*.

Clerk Brown noted the projector would be arriving later in the week and the screen is already in the Village's possession. All that remains is to construct the frame.

Councilor Wilson asked about advertising, to which Mayor Bruton replied the event would be advertised through the newsletter, social media, and possibly the media. Mayor Bruton added the first showing will be free, after which the Village will charge \$10.00 per vehicle.

10. Council to Discuss Providing Additional Leveraged Funds to Complete Full Project Scope for CDBG Senior Center Phase 3 Project

Clerk Brown noted the Senior Center Phase III grant is going out to bid this weekend. She added that the construction will be about 20 percent more expensive than when the project was designed due to inflation. The Department of Finance and Administration has directed the Village to complete the entire project scope to the best of its ability. In order to do so, Clerk Brown stated, the Village will likely need to allocate additional funding to the project. She presented two possible scenarios, one in which the Village pays to repair a damaged wall and the other in which the Village covers the excess scope of Phase III.

Mayor Bruton noted if the original contractors who constructed the damaged wall are still in business, he will pursue having the contractor pay for the repairs.

Councilor Johnson asked about the timeframe for making the decision. Clerk Brown stated she should know more about the budget shortfall in the coming weeks, after selection of a contractor. She suggested revisiting the conversation at the first meeting in November.

Clerk Brown stated completing the entire project scope will improve the Village's likelihood of receiving the same funding in future years, which would be helpful in realizing Village projects such as expanding wastewater facilities.
