

### SENIOR CENTER EXPANSION

#### Councilor Maxine Wilson, Mayor Pro Tempore


We are excited to announce that construction on the Senior Center expansion will begin on Monday, March 15th! The project will add an entire new wing to the Senior Center, creating space for a larger dining hall, a new fitness center, and additional classrooms. We anticipate construction to be completed in December.

As a result of the construction, the grab-and-go meal site will be relocated to Village Hall beginning on Monday, March 15th. We will be distributing meals out of the maintenance building located next to Village Hall at 12 Camino Municipal. Our staff will be on site to help direct you to the new location. We will continue to distribute meals at Village Hall until the Senior Center construction is completed.



#### **Tijeras Park and View**

The inaugural showing of the Tijeras Park and View on February 27th was a tremendous success! Thank you to everyone who attended, volunteered, and donated to the project. ## 2020 HAZARD MITIGATION PLAN

The Village of Tijeras has been working on updating the Albuquerque/Bernalillo County Hazard Mitigation Plan, which describes hazards that could threaten the Albuquerque/Bernalillo County area such as floods, wildfires, or severe weather; analyzes their potential impacts; and identifies ways to reduce impacts through long-term, sustainable mitigation projects.

This updated plan improves upon the 2015 plan and identifies new opportunities and strategies to reduce vulnerabilities and increase resiliency and sustainability in our communities. Bernalillo County, the City of Albuquerque, the Village of Los Ranchos de Albuquerque, the Village of Tijeras, Albuquerque Metropolitan Arroyo Flood Control Authority (AMAFCA), the Middle Rio Grande Conservancy District (MRGCD), and the Albuquerque/Bernalillo County Water Utility Authority (ABCWUA) are participating in this planning project to reduce losses from future disasters.

Jurisdictions must update their hazard mitigation plans and resubmit them for FEMA approval every five years in order to be eligible for receiving certain types of non-emergency disaster assistance, including funding for mitigation projects.
