# 7. Council to Review and Approve the Amendment Structure Lease Agreement with AT&T

Mayor Bruton noted the Council last discussed this agreement in 2019 and that it expires in four days. He asked if the Village attorney had reviewed the agreement. Clerk Brown replied the attorney reviewed the agreement in the early stages.

Clerk Brown explained the agreement reflects an increase in rent due to the addition of a new backup generator. Mayor Bruton clarified that the increase is \$250 and AT&T is installing a new concrete pad and backup generator in compliance with the federal First Net program to provide continuous wireless service to first responders in the event of power outages.

Councilor Ortiz asked for additional details about the lease agreement. Mayor Bruton explained AT&T leases space on the Village's water tower as well as some space on the ground adjacent to the tower. Clerk Brown added AT&T pays \$1,250 per month to lease the space and, pursuant to the agreement, the lease fee increases by 15 percent per year.

Mayor Bruton noted the Village is extending the agreement by one year, at which point they will renegotiate with AT&T.
