  - i. Vallecitos Quote

Clerk/Manager A. Caufield – Revised quote to include road and slope repair, haven't received confirmation on any grant funds we may have available to use for this project.

Councilor M. Armenta – Funds were used to fix this problem in the past if we spend funds again what if this happens again. See if we can hold off and apply for a grant to use to look for a better solution to make sure what's done is a long-term fix.

Councilor Y. Garcia – The last time this was done it started cracking right after the warranty expired. Is this causing any other destruction or is it a cosmetic fix? Speak to Molzen for other solutions that will work long term.

Councilor E. Barnes – If they're just going to seal the cracks that's not going to solve our problem, that's moisture and sealing is not going to work long term.

Mayor Bruton – We can wait and talk to Molzen to see what our options are. It's not causing any other destruction but eventually will. Speak to the county on possibly splitting the cost.
