- i. Carmino/Criswell project set to start on Monday 07/28/2025. Spear D will be placing door hangers but if you all talk to residents in that area, please let them know. Drove around today and saw that we might have access to our open space off Criswell and might look at that during construction.
- ii. Mexico trip to deliver the fire truck went smooth, firefighters were so happy. This is the newest firetruck they now have on their fleet. (Councilor Y. Garcia That's great to hear.) Asked if they were willing to take the 1988 that we have out here, and they said yes and they will make the trip to pick it up. If you guys are ok with donating, we will have a resolution at our next meeting.
- Flooding Working with Bernalillo County to see if there are any funds available to do some iii. reclamation. Looking for funds for the park damage. Culverts have plenty of space for water, but all the damage was caused by all the debris build up. Municipal league told us that open space is not covered. Will look at applying for grant to rebuild and using funds from existing open space grant to pay for our match portion. Thank you, Matt, for all the work done and for taking the rein with cleaning up all the debris along with Hector and Leon. (Councilor M. Armenta – It's unfortunate that we lost the park, but we had thoughts about moving our concert series there, imagine what it would've been if we would've had it there. Parks can be replaced but lives can't, and we must be thankful.) That is correct and I will do what I can do to repair the park and find funds. Spoke to Bernalillo County about all coming together and working together to get the arroyo cleaned up and decide who will maintain. (Councilor J. Ortiz – Next year maybe instead of doing an Earth Day with our residents we should come together and clean out all the debris in the arroyos. Also, should look at how to protect the corner of the park from future damage with the water/debris coming over.) (Councilor E. Barnes – Have the bridges been inspected?) Working with Bernalillo County Emergency Management on getting a certified inspector to come out.
