- iii. Have we heard back from NMDOT about the speed limit signs. (Clerk/Manager A. Caufield An email was sent to District 3 Engineer Paul Brasher requesting to put additional 35MPH signs up. Will update once we get a response) Can we also reach out regarding speed coming out of Kay Rd. (Councilor J. Ortiz- Can we possibly reach out to the county and have them place speed camera.)
- iv. Thank Audrey as she was able to locate agreement/minutes regarding Bernalillo Couty Fire with regards to placing Village of Tijeras decals on the fire trucks that service our area.

E. Barnes

- i. Thank Village staff for hard work with the Veteran's Day Memorial Event it looked great, and I would like to see more like that.
- Pine View? (Mayor Bruton We will not be able to move TPF funds to make project of ii. Pine View whole. Trying to get a hold of Mr. Kubiak but haven't been able to speak with him. Currently at a standstill.) (Councilor J. Ortiz – So the TPF funds that were awarded will not be able to be moved? Mayor Bruton – That is correct. Engineers dropped the quote a bit but still short on funding.) (Councilor M. Armenta – Were we going to phase the project? Clerk/Manager A. Caufield – Short about \$660k, suggest that we phase as we have a grant that will expire June 30, 2026. Have the largest and smallest road done first and wait on the last road until we have enough funds.) We should have a discussion before we decide how to phase this project. When would the work start? (Clerk/Manager A. Caufield – We can schedule a special meeting for next week for you all do decide how to phase the project and award to contractor.) (Councilor J. Ortiz – Are TPF funds that were awarded for future projects? Clerk/Manage A. Caufield – Those funds are only for Los Vallecitos improvements.) (Attorney J. Nixon – Audrey just to clarify the funds that we have for Pine View must be spent by June 30th? Clerk/Manager A. Caufield – That is correct they must be spent by June 30, 2026.) (Mayor Bruton – Engineers already worked on separate costs, we can have a special meeting next week and decide how we want to phase out this project. Special meeting Monday November 24, 2026, at 3:00PM.)
- iii. Speaker system used during the Veteran's Event not functioning well. (Clerk/Manager A. Caufield Will look at purchasing a new system for future events.)

Garcia – Thank Hector and Jeremy for removing and getting rid of all the brush/debris from the yard here as it was attracting rodents, thank you all for allowing them time to work on that. Request that the guy's trim/cut the branches at the intersection of Patricio Garcia & Route 66. (Councilor J. Ortiz – Yes, I was in the back and couldn't hear very well.) (Clerk/Manager A. Caufield – They will start on weeds and trees this week.)

- i. Fire Hydrant Painting Spoke to Chief Valenzuela and he stated that we cannot paint them.
- ii. Senior Center Drive Councilor Garcia thank you for the idea. Rita is working on a flyer for donations and will have the drive open from November 20th December 19th and will distribute items the Monday before Christmas.
