- Mayor Bruton As you all know we are short on funding for the complete project and am proposing to
  phase while we get more funding. Waiting on calls in hopes that we can get additional funding to
  complete the project. We weren't able to transfer the TPF funds to complete this project and can only
  be used for Los Vallecitos. Vanessa and Jonah from Molzen split up the project since it's three separate
  roads.
- Vanessa Roads were split up with three separate costs and we just need to know what roads you all would like to work on with the current funding.
- Clerk/Manager A. Caufield Suggestion to Council is that we fund Pine View Road and Pine View Place and complete Pine View Crest in phase two. Attached is also a breakdown of current funds along with cost breakdown for each road. There will be a call for MAP funds in January. (Vanessa That is correct MAP and COOP are due in the middle of March and TPF due end of June.)
- Mayor Bruton Agree with the breakdown that Audrey has presented to you all. We will keep working on looking for additional funding.
- Councilor J. Ortiz Can we hold off on the whole project until we secure more funding? (Clerk/Manager A. Caufield Unfortunately not as the funds must spent and the contractors will have to do \$700K worth of work before June 30, 2026.) (Mayor Bruton We have to get contractors started soon to get funds spent or we run the risk of losing funds and we don't want that to happen.)
- Councilor E. Barnes Mayor I think that's a good approach. Spoke to some of the residents about this
  they feel like if Pine View Road gets done as this is the main road, they're ok with it. Pine View Place
  will also be included which will be sufficient until we get funds for the last road. (Mayor Bruton –
  Appreciate that feedback thank you.)
- Councilor M. Armenta Thank you all for working hard to try and find a solution to try and make this project whole. Also agree that we get two full roads completed instead of phasing a road. Great idea to start with Pine View Road and Pine View Place.
